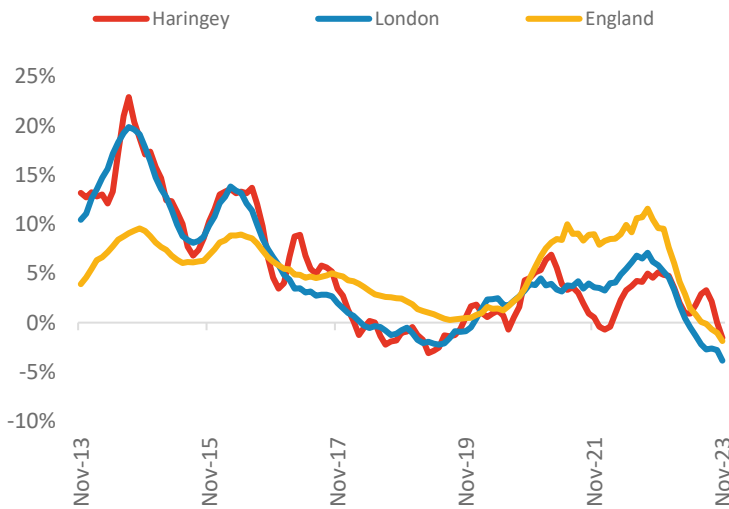

### House Prices (November 2023 data)

#### Annual Change in House Prices

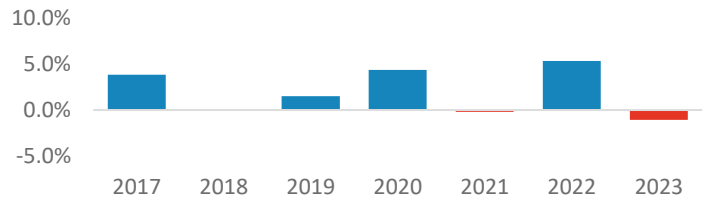


House prices in Haringey fell by 1.5% in the 12 months to November 2023 (based on 3-month smoothed data). By comparison national house prices fell by 1.9% and prices in London fell by 3.9% over the same period.

Haringey house prices are now 85.0% above their previous peak in 2007, compared to +73.6% for London and +56.6% across England.

Local prices have fallen by 1.1% in 2023 so far, compared to growth of 5.4% over the same period in 2022.

#### Year-To-Date Change in House Prices, December to November

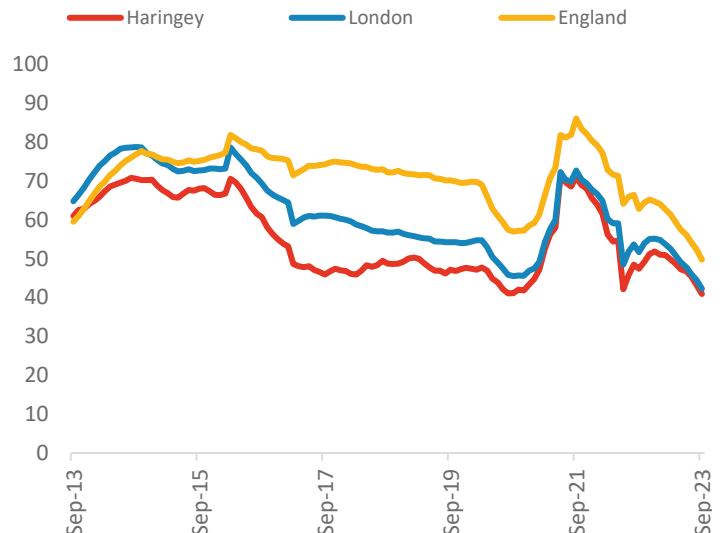


### Transactions (September 2023 data)

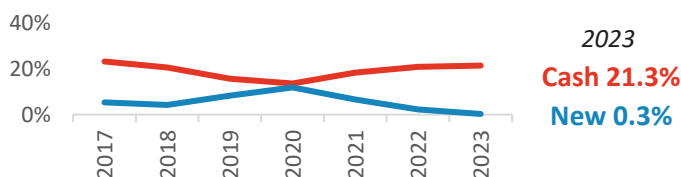
There were 1,703 transactions in Haringey during the 12 months to September 2023. This is 41% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Haringey have fallen by 41.8% since 2014, compared to changes of -44.8% for London and -35.3% for England.
