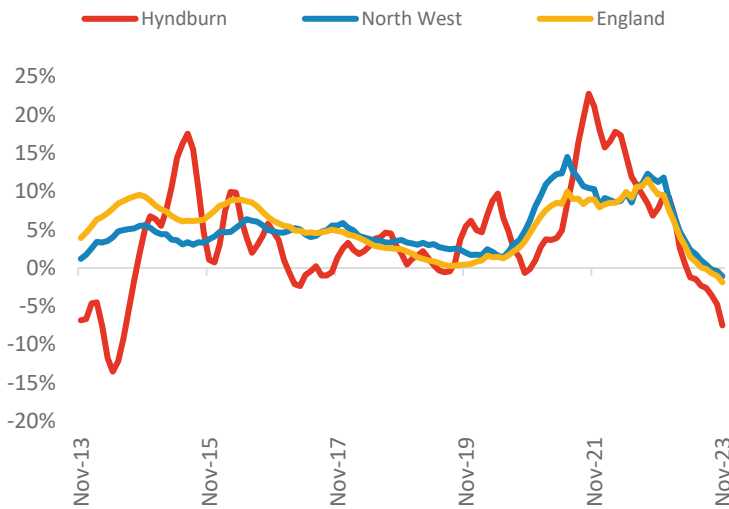

### House Prices (November 2023 data)

#### Annual Change in House Prices



House prices in Hyndburn fell by 7.5% in the 12 months to November 2023 (based on 3-month smoothed data). By comparison national house prices fell by 1.9% and prices in the North West fell by 1.1% over the same period.

Hyndburn house prices are now 10.8% above their previous peak in 2007, compared to +41.7% for the North West and +56.6% across England.

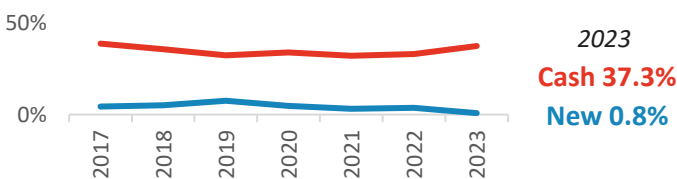
Local prices have fallen by 7.5% in 2023 so far, compared to growth of 9.4% over the same period in 2022.

### Transactions (September 2023 data)

There were 936 transactions in Hyndburn during the 12 months to September 2023. This is 40% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Hyndburn have fallen by 20.1% since 2014, compared to changes of -25.3% for the North West and -35.3% for England.

#### Cash and New Build Sales as % of Total, by Year\*

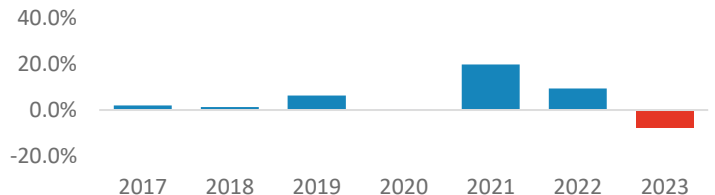
