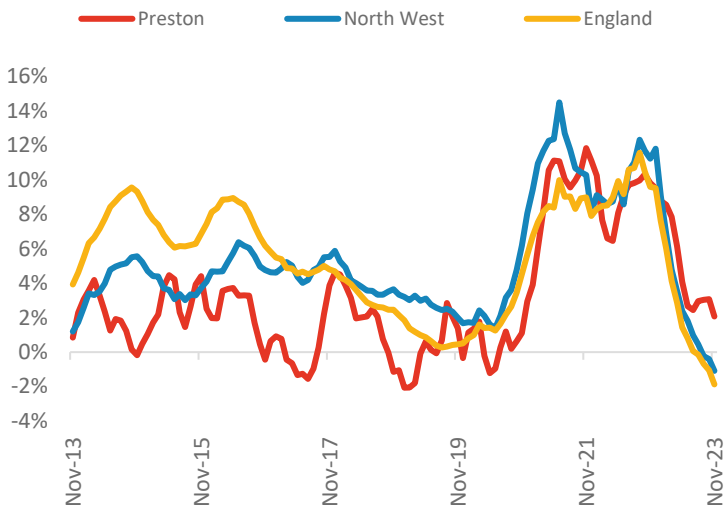

Annual Change in House Prices

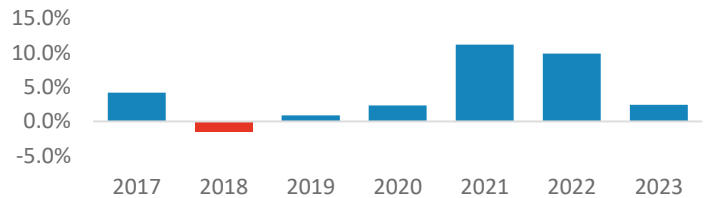


House prices in Preston grew by 2.1% in the 12 months to November 2023 (based on 3-month smoothed data). By comparison national house prices fell by 1.9% and prices in the North West fell by 1.1% over the same period.

Preston house prices are now 15.3% above their previous peak in 2007, compared to +41.7% for the North West and +56.6% across England.

Local prices have grown by 2.4% in 2023 so far, compared to growth of 9.9% over the same period in 2022.

Year-To-Date Change in House Prices, December to November

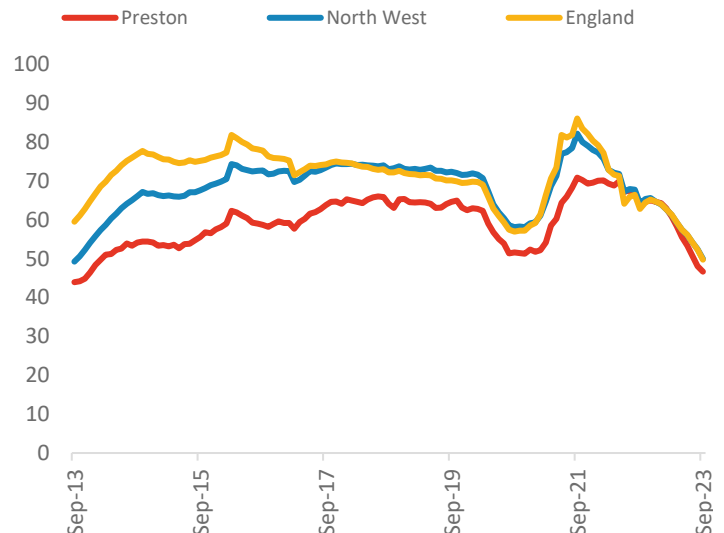


Transactions (September 2023 data)

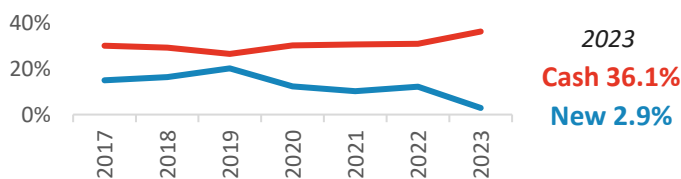
There were 1,507 transactions in Preston during the 12 months to September 2023. This is 47% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Preston have fallen by 13.8% since 2014, compared to changes of -25.3% for the North West and -35.3% for England.
