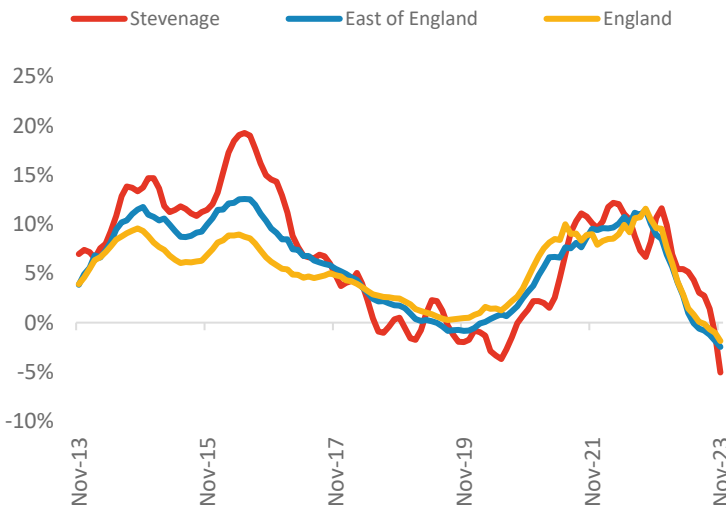

Annual Change in House Prices

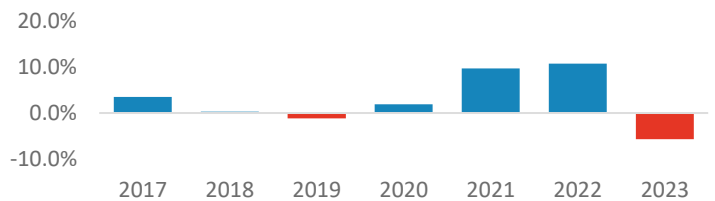


House prices in Stevenage fell by 5.1% in the 12 months to November 2023 (based on 3-month smoothed data). By comparison national house prices fell by 1.9% and prices in the East of England fell by 2.5% over the same period.

Stevenage house prices are now 72.9% above their previous peak in 2007, compared to +66.6% for the East of England and +56.6% across England.

Local prices have fallen by 5.7% in 2023 so far, compared to growth of 10.8% over the same period in 2022.

Year-To-Date Change in House Prices, December to November

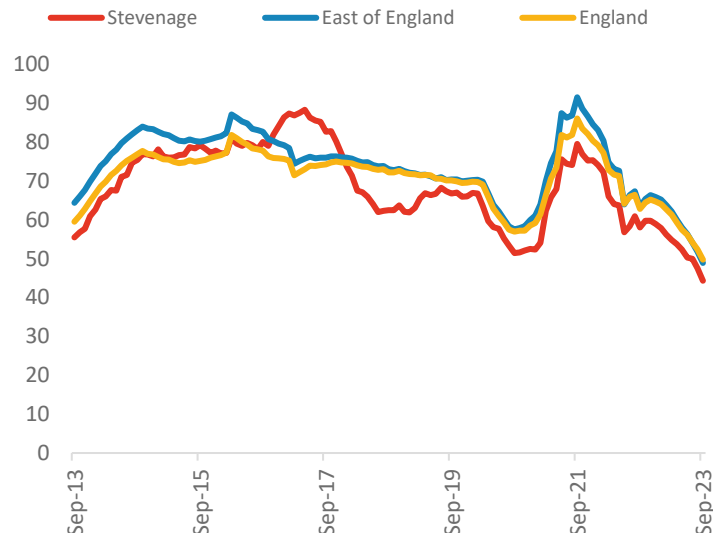


Transactions (September 2023 data)

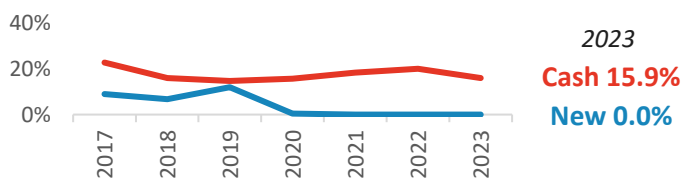
There were 766 transactions in Stevenage during the 12 months to September 2023. This is 44% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Stevenage have fallen by 41.9% since 2014, compared to changes of -41.3% for the East of England and -35.3% for England.
