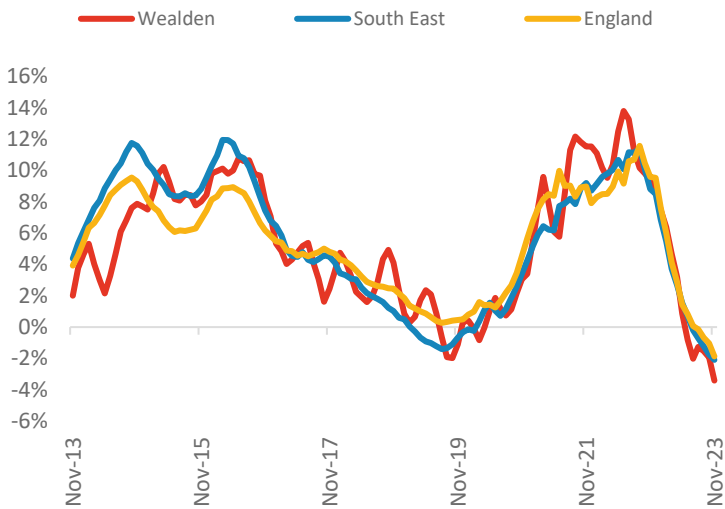

### House Prices (November 2023 data)

#### Annual Change in House Prices

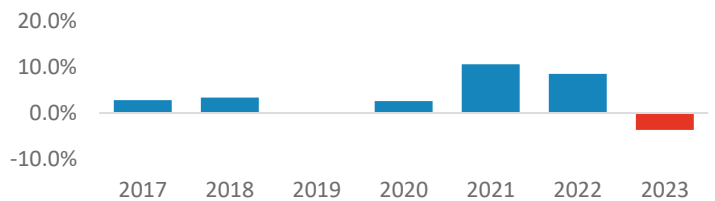


House prices in Wealden fell by 3.4% in the 12 months to November 2023 (based on 3-month smoothed data). By comparison national house prices fell by 1.9% and prices in the South East fell by 2.1% over the same period.

Wealden house prices are now 54.0% above their previous peak in 2007, compared to +62.7% for the South East and +56.6% across England.

Local prices have fallen by 3.7% in 2023 so far, compared to growth of 8.6% over the same period in 2022.

#### Year-To-Date Change in House Prices, December to November

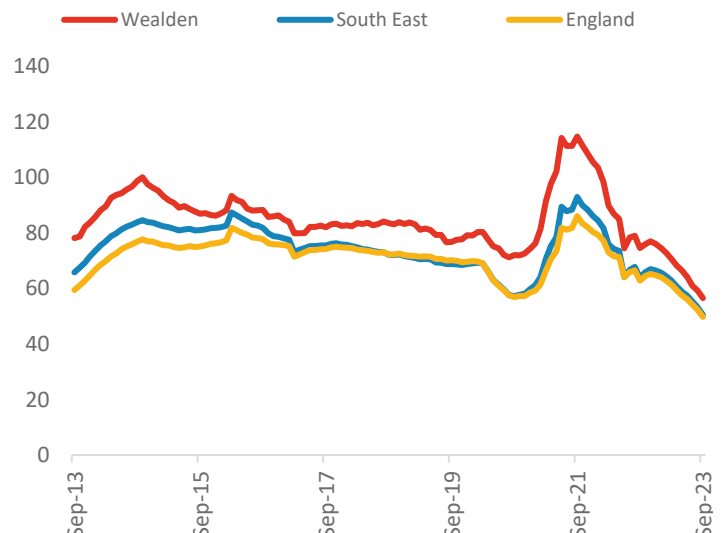


### Transactions (September 2023 data)

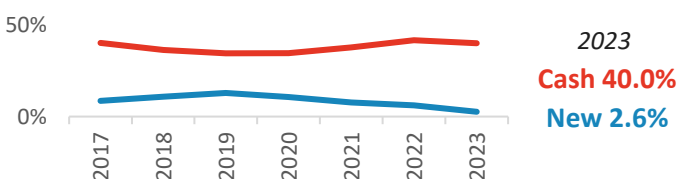
There were 1,917 transactions in Wealden during the 12 months to September 2023. This is 56% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Wealden have fallen by 41.3% since 2014, compared to changes of -39.7% for the South East and -35.3% for England.
