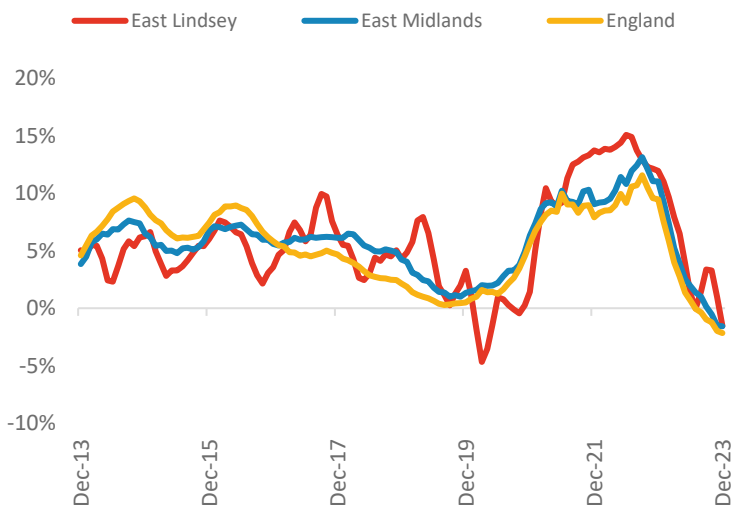

Annual Change in House Prices

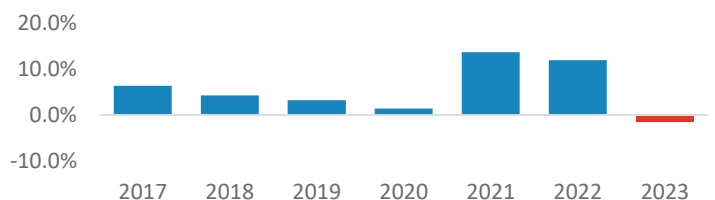


House prices in East Lindsey fell by 1.5% in the 12 months to December 2023 (based on 3-month smoothed data). By comparison national house prices fell by 2.2% and prices in the East Midlands fell by 1.6% over the same period.

East Lindsey house prices are now 45.9% above their previous peak in 2007, compared to +55.4% for the East Midlands and +55.8% across England.

Local prices have fallen by 1.5% in 2023 so far, compared to growth of 12.0% over the same period in 2022.

Year-To-Date Change in House Prices, December to December

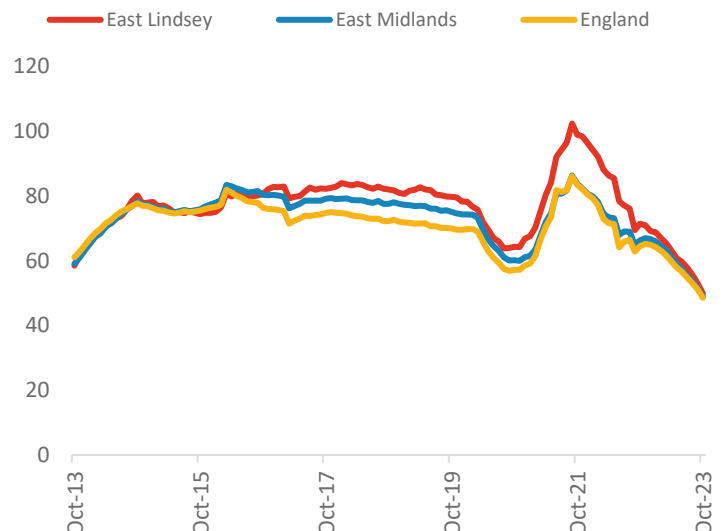


Transactions (October 2023 data)

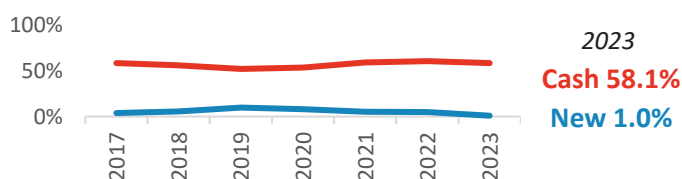
There were 1,616 transactions in East Lindsey during the 12 months to October 2023. This is 50% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in East Lindsey have fallen by 36.0% since 2014, compared to changes of -36.7% for the East Midlands and -36.8% for England.
