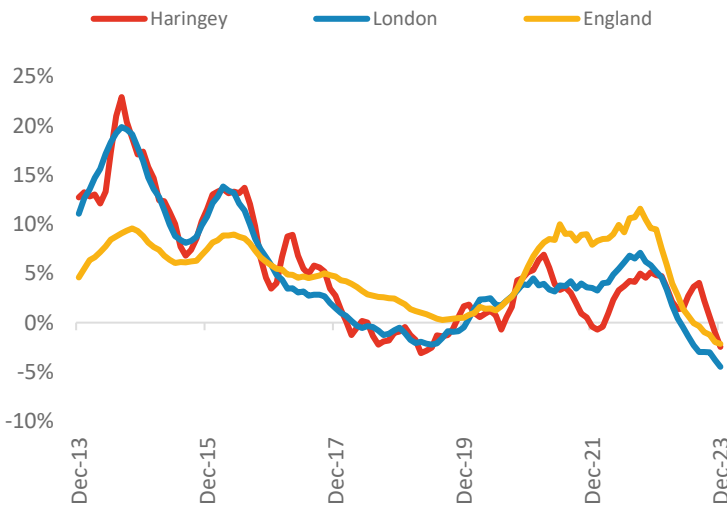

#### Annual Change in House Prices

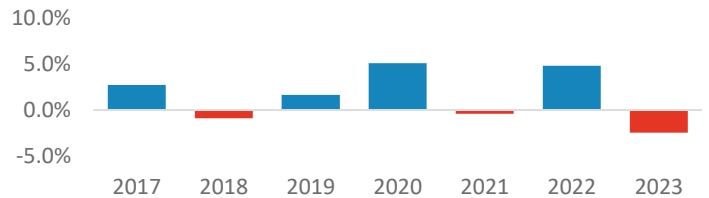


House prices in Haringey fell by 2.5% in the 12 months to December 2023 (based on 3-month smoothed data). By comparison national house prices fell by 2.2% and prices in London fell by 4.5% over the same period.

Haringey house prices are now 82.3% above their previous peak in 2007, compared to +71.5% for London and +55.8% across England.

Local prices have fallen by 2.5% in 2023 so far, compared to growth of 4.8% over the same period in 2022.

#### Year-To-Date Change in House Prices, December to December

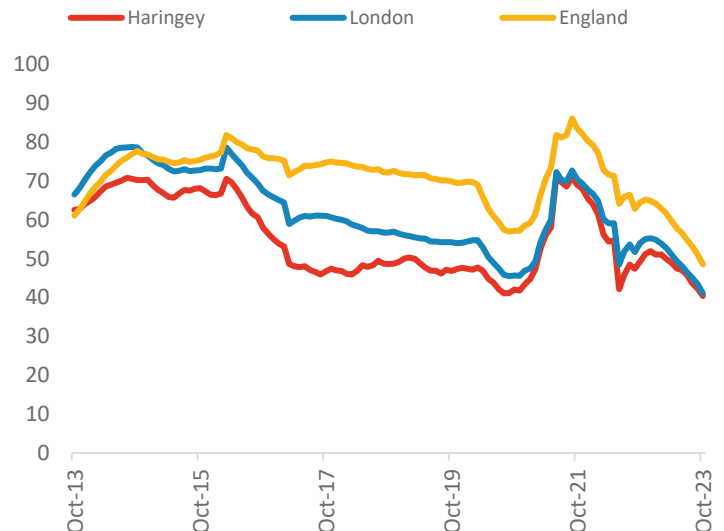


### Transactions (October 2023 data)

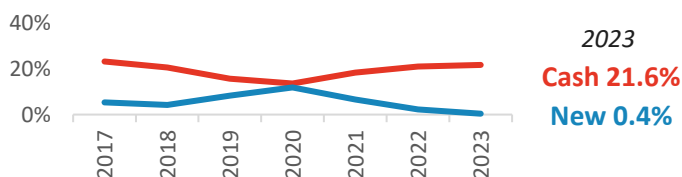
There were 1,681 transactions in Haringey during the 12 months to October 2023. This is 40% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Haringey have fallen by 42.5% since 2014, compared to changes of -46.3% for London and -36.8% for England.
