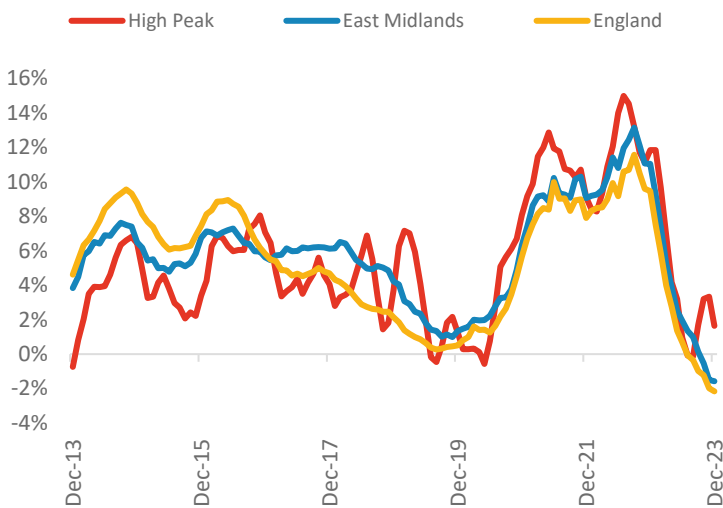

Annual Change in House Prices

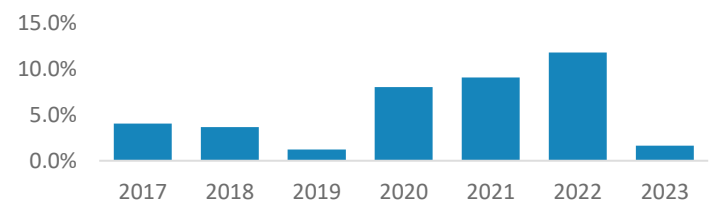


House prices in High Peak grew by 1.6% in the 12 months to December 2023 (based on 3-month smoothed data). By comparison national house prices fell by 2.2% and prices in the East Midlands fell by 1.6% over the same period.

High Peak house prices are now 49.0% above their previous peak in 2007, compared to +55.4% for the East Midlands and +55.8% across England.

Local prices have grown by 1.6% in 2023 so far, compared to growth of 11.8% over the same period in 2022.

Year-To-Date Change in House Prices, December to December

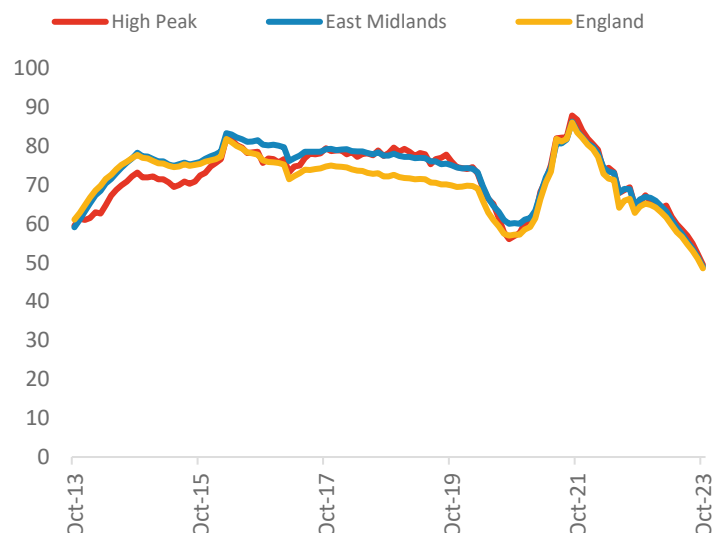


Transactions (October 2023 data)

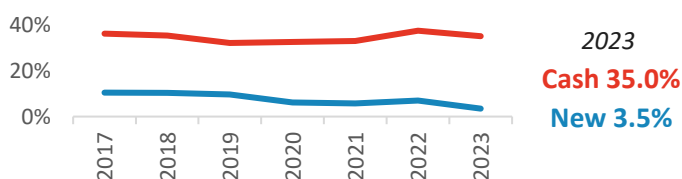
There were 1,053 transactions in High Peak during the 12 months to October 2023. This is 49% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in High Peak have fallen by 31.3% since 2014, compared to changes of -36.7% for the East Midlands and -36.8% for England.
