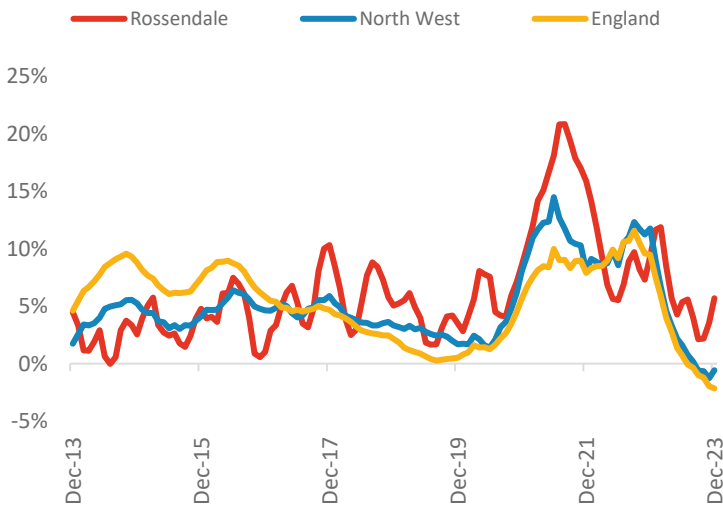

#### Annual Change in House Prices

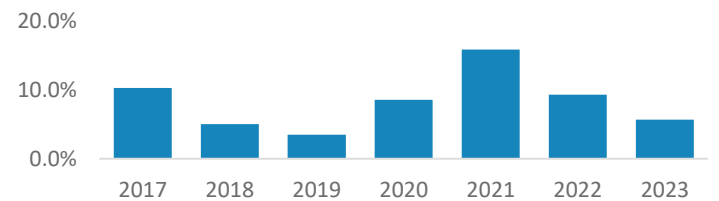


House prices in Rossendale grew by 5.7% in the 12 months to December 2023 (based on 3-month smoothed data). By comparison national house prices fell by 2.2% and prices in the North West fell by 0.6% over the same period.

Rossendale house prices are now 57.3% above their previous peak in 2007, compared to +42.3% for the North West and +55.8% across England.

Local prices have grown by 5.7% in 2023 so far, compared to growth of 9.4% over the same period in 2022.

#### Year-To-Date Change in House Prices, December to December

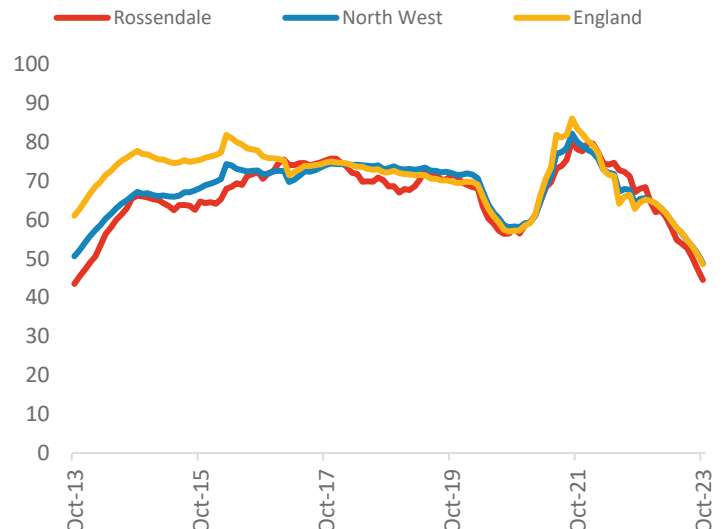


### Transactions (October 2023 data)

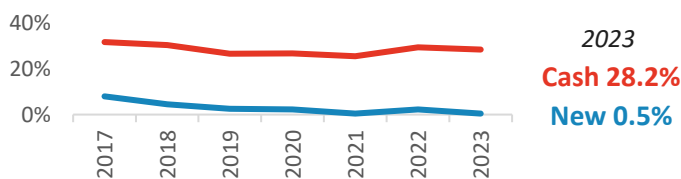
There were 779 transactions in Rossendale during the 12 months to October 2023. This is 45% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Rossendale have fallen by 32.3% since 2014, compared to changes of -27.1% for the North West and -36.8% for England.
