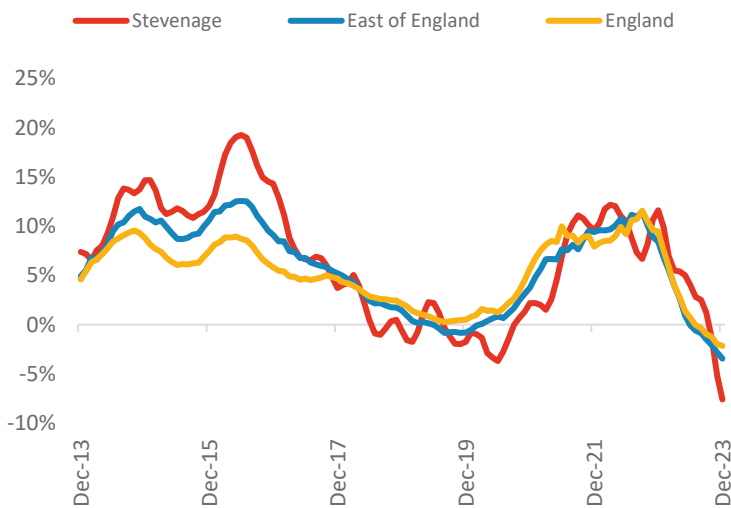

Annual Change in House Prices

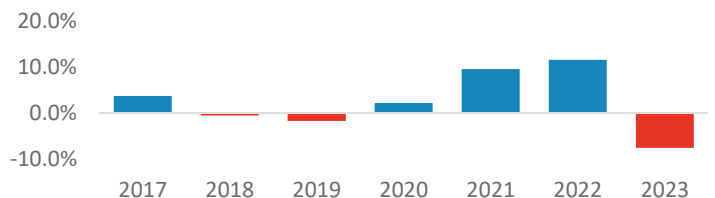


House prices in Stevenage fell by 7.6% in the 12 months to December 2023 (based on 3-month smoothed data). By comparison national house prices fell by 2.2% and prices in the East of England fell by 3.5% over the same period.

Stevenage house prices are now 69.5% above their previous peak in 2007, compared to +64.7% for the East of England and +55.8% across England.

Local prices have fallen by 7.6% in 2023 so far, compared to growth of 11.6% over the same period in 2022.

Year-To-Date Change in House Prices, December to December

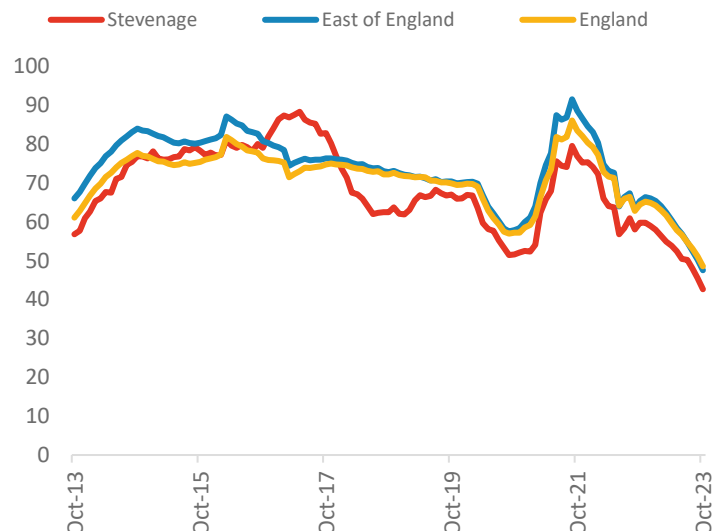


Transactions (October 2023 data)

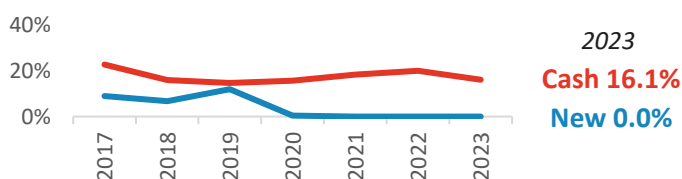
There were 737 transactions in Stevenage during the 12 months to October 2023. This is 43% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Stevenage have fallen by 44.1% since 2014, compared to changes of -43.0% for the East of England and -36.8% for England.
